ASSUMPTION OF THE RISK AND RELEASE OF LIABILITY

I also understand that such risks are inherent to bicycle riding, which include bicycle equipment, roads, traffic, weather and other conditions which may affect safe riding and also risks which are also caused by my negligence and negligence of other people (including negligent rescue) who may be riding bicycles with me or who may participate in any bicycle event in which I might ride. I HEREBY ACKNOWLEDGE AND ASSUME ALL RISK OF MY DEATH, INJURY AND PROPERTY LOSS WHICH MIGHT RESULT FROM MY PARTICIPATION IN ANY AND ALL BICYCLING ACTIVITY SPONSORED, CONTROLLED AND OR ORGANIZED BY THE STUMP GRINDER BICYCLE CLUB (SGBD), SG PRODUCTIONS (SGP), STUMP GRINDER DIRT CLUB (SGDC) AND OR THE MEMBERS, OFFICERS, VOLUNTEERS OR OWNERS THERE OF.

Although no member, officer, volunteer or owner of the SGBD, SGP, & SGDC, owes any duty to rescue me in event I suffer an injury or loss while riding a bicycle, this waiver also applies to any injury, death or loss which I might suffer by reason of negligent rescue by any member, officer, volunteer or owner of the SGBD, SGP, SGDC AND in any bicycle event sponsored, controlled, and or organized by the SGBD, SGP, & SGDC.
